MIS Committee February 7, 2016

The Mission Interpretation and Stewardship (MIS) Committee met February 7th in the Sanctuary immediately following the morning Worship Service. Although this was a called meeting, it will serve as our bi-monthly Committee meeting since it addressed all the known business for January and February.

Attendance: Paul Burkey (Chair), Receiving Treasurer Marilyn Brumley, Disbursing Treasurer Sandra Carter, Doyle Edmondson, Joyce Whittenburg, and Doug Roberts. Brian Wyatt sat in as well.

The Committee addressed two urgent pieces of business:

1) Review and approve the Special Offering schedule for 2016. Paul proposed and the Committee agreed by consensus to the following:

One Great Hour of Sharing

2) Make a recommendation to Session for augmenting the General Fund checking account whose balance had fallen to approximately \$4000 (We generally become concerned when that balance is below \$10,000).

There are two potential sources of cash to replenish the General Fund coffers: the sale of shares from the Church's New Covenant Balanced Funds that are associated with the Operating Fund and the Cemetery Fund checking account, which has a relatively healthy balance of \$22,893. We discussed the bad timing for selling Fund shares directly as the shares have lost 16 percent of their value in the last 14 months (5 percent of that loss was in the last 6 weeks). Paul proposed taking a \$9000 cash loan (roughly the net income/expense deficit for our General Fund in 2015) from the Cemetery Fund with intention to sell New Covenant shares to repay the loan when the price per share has recovered. The Committee discussed but chose not to recommend a specific repayment deadline.

After discussion concluded, Joyce moved and Doyle seconded the following motion:

The MIS Committee recommends that the Session approve a loan of \$9000 from the Cemetery Fund checking account to the General Fund Checking account. Also, the Committee requests Session approve the sale of New Covenant shares up to the value of the loan to repay the Cemetery Fund when the New Covenant Fund price per share recovers to \$100 per share.

The motion passed unanimously.

The Committee noted that if General Fund Offerings exceed what is necessary to cover our annual budget, the surplus could be used to offset the number of shares we have to sell to make the loan repayment.

The meeting was adjourned. The next MIS Committee meeting will be in April.
